SUBJECT

The topic of these Vigoni-talks will be the Italian and German welfare states - seen in a Westeuropean, comparative perspective. Both welfare states are usually labeled as 'Catholic'. But what does this mean today? We will look at the party-political context, the ideological background and the institutional heritage of the Italian and the German systems of social protection. We will address the following questions, amongst others: what is the role of Christian Democracy, in past and present, in Italian and German social policy? How have family- and education-policy changed in both countries? Do we still observe a religious vote in Italy and Germany, what is the role of the state/ church cleavage today? Have women's labor market participation and changed family pattern had an impact on female voting behavior? The discussion between Italian, German and international experts from political science, sociology and history will address these and other questions in the stimulating setting of the Villa Vigoni.
